Through the power of God's word and the Holy Spirit addictions and harmful sexual and violent behaviors are broken and relationships with God, others and themselves are restored. Students are taught life skills, equipped to serve their nation and connected with a local church. HTC partners closely with Rendez-Vous Christ Church (RVC). RVC was started in 2016 by HTC graduates who were rejected by the local church because of their past. Today, they serve as church leaders, Sunday school teachers, welcomers and small group leaders. RVC reaches over 5,000 Haitians weekly through services at four campuses and social media and its services are
